

Terms and Conditions for "500 Tickets to Bali Giveaway!"

These are the legal terms for our "500 Tickets to Bali Giveaway!" Lucky Draw (organised by us, Trust Bank Singapore Limited). Trust customers who hold a valid Trust credit card or savings account between 17 May 2024 till 15 July 2024 may participate in this Lucky Draw – this is the promotion period.

Who can participate?

This draw is open to any Trust customer whose Trust account is valid (not suspended or terminated) and in good standing (as decided by us).

- A. For new to Trust customers, you get one (1) draw chance upon successful sign up as a Trust customer during promotion period.
- B. For existing Trust customers, you get one (1) draw chance when you successfully refer someone else to be a new customer of Trust using your assigned referral code during the promotion period .
- C. For existing Trust customers, you get one (1) draw chance for every foreign currency card spend transaction during the promotion period.

Chances earned from (A) & (B) are capped at twenty (20) chances. Chances earned from (C) is capped at twenty (20) chances. You may earn up to a total of forty (40) chances.

The following transactions are not qualifying transactions: (i) betting and gambling related transactions and (ii) cash withdrawals.

When will the draw be conducted?

What will you win?

The prize for each winning Trust customer is a pair of air tickets to Bali. We are giving away a total of 250 prizes over a single draw.

The prize is capped at \$\$900. If cost of the prize exceeds \$\$900, you will need to pay for the additional costs using your Trust card. You will be responsible for contacting our appointed travel partner to redeem the prize and conclude a booking.

All bookings must be a single destination flight departing from Singapore to Bali and returning from Bali to Singapore with no stopovers. The pair of return flight tickets must be redeemed and booked in the same booking. You must be one of the passengers.

You are responsible for all taxes payable on the prize.

You agree that in order to redeem the prize, we and our appointed travel partner may impose any additional terms and conditions. For example, we or our appointed travel partner may impose blackout periods where the prize cannot be redeemed. Such additional terms and conditions will be made known to you when we give you the prize.



What happens if you win?

If you win, you have to accept the prize as it is. You cannot request for us to transfer it to someone else or exchange this for credit or cash.

To ensure that you are aware that you have won, we will notify you and may publish your name on the Trust website within 7 working days from the Draw date.

If you win, you must acknowledge within 7 days from the date we notify you that you have won. If you fail to acknowledge within 7 days, your prize will be forfeited and given to the next winner. We will draw up to an additional 50 potential winners for each draw.

You consent to us disclosing and/or publishing your name, particulars and photographs for publicity activities organised or endorsed by us. You must participate in any publicity activity organised or endorsed by us without expecting any compensation from us. You cannot speak to the press or any media regarding the Lucky Draw without our consent.
